Illinois Residency Verification Form

You may be eligible for an ISAC MAP grant. The college is required to verify Illinois residency before an award can be made. MAP grants are tuition scholarships.

☐ Independent (Acceptable Residency Documentation--only one is required):

ISAC qualifications for an independent student for the 2020-2021 award year:

An <u>independent</u> student is a resident of Illinois if the applicant physically resides within the State of Illinois (at the time of application), and has so resided for a period of 12 continuous, full months immediately prior to the start of the academic year for which assistance is requested and Illinois is his or her true, fixed, and permanent home.

In order to qualify for a MAP Grant as an Independent student for the 2020-2021 award year, one of the following from the list below are required.

- A copy of 2019 Illinois state tax return.
- A copy of 1099-Misc. Income for 2019.
- Statement of benefits from the Illinois Department of Employment Security
- > Statement of benefits history from the Illinois Department of Healthcare and Family Services or Social Security Administration showing that you received benefits from 8-1-19 to 8-31-20 or to current date.
- An Illinois high school or college transcript with dates of attendance from 08-19 to 05-20.
- A copy of your Illinois driver's license issued prior to 8-16-19.
- A state of Illinois identification card issued prior to 8-16-19.
- A copy of your Illinois auto registration card (in your name) issued prior to 8-16-19.
- > Copies of the utility bills, rent receipts, or residential lease in your name showing that you lived at an Illinois address from 8-1-19 to 8-31-20 or to current date for **each** month.

□ Dependent (Acceptable Residency Documentation--only one is required):

ISAC qualifications for a dependent student for the 2020-2021 year:

A <u>dependent</u> student is a resident of Illinois if the parent of the dependent-applicant, who is required by the instructions to complete the Free Application for Federal Student Aid (FAFSA), physically resides within the State of Illinois and Illinois is his or her true, fixed, and permanent home.

In order to qualify for a MAP Grant as a dependent student for the 2020-2021 award year, one of the following from the list below are required.

- > A copy of your parent's 2019 Illinois state tax return or tax transcript that shows an Illinois address
- A copy of 1099-Misc. Income for 2019.
- A state of Illinois identification card issued to your parent prior to 8-16-19.
- A copy of your parent's Illinois auto registration card issued prior to 8-16-19.
- A copy of your parent's Illinois driver's license issued prior to 8-16-19.
- Copies of utility bills, rent receipts, or residential leases verifying an Illinois address for your parent issued prior to 8-16-19. (6 months)
- > Statement of benefits from the Illinois Department of Employment Security
- > Statement of benefits history from the Illinois Department of Healthcare and Family Services or Social Security Administration showing that your parent received benefits for each month during the year of 2019.
- Property tax bill.

All documentation must be typed on agency letterhead. Handwritten documents are not acceptable.
