- Statement of benefits history from the Illinois Department of Public Aid or Social Security Administration showing that you received benefits from 8-1-18 to 8-31-19 or to current date.
- > An Illinois high school or college transcript with dates of attendance from 08-18 to 05-19.
- > A copy of your Illinois driver's license issued prior to 8-16-18.
- A state of Illinois identification card issued prior to 8-16-18.
- > A copy of your Illinois auto registration card (in your name) issued prior to 8-16-18.
- Copies of the utility bills, rent receipts, or residential lease in your name showing that you lived at an Illinois address from 8-1-18 to 8-31-19 or to current date for **each** month.

Dependent (Acceptable Residency Documentation--only one is required):

ISAC qualifications for a dependent student for the 2019-2020 year:

A <u>dependent</u> student is a resident of Illinois if the parent of the dependent-applicant, who is required by the instructions to complete the Free Application for Federal Student Aid (FAFSA), physically resides within the State of Illinois and Illinois is his or her true, fixed, and permanent home.

In order to qualify for a MAP Grant as a dependent student for the 2019-2020 award year, one of the following from the list below are required.

- > A copy of your parent's 2018 Illinois state tax return or tax transcript that shows an Illinois address
- > A copy of 1099-Misc. Income for 2018.

- Statement of benefits history from the Illinois Department of Public Aid or Social Security Administration showing that your parent received benefits for each month during the year of 2018.
- Property tax bill.
